Introduction

The NDIS Quality and Safeguards Commission (NDIS Commission) is committed to measuring outcomes for NDIS participants and assessing regulatory impact.

This report provides an overview of the NDIS Commission's performance and regulatory operations from 1 April 2025 – 30 June 2025.

Key statistics from this report include:

- A 75% increase in number of complaints closed this quarter, and a decrease in the percentage of complaints closed within 90 days, from 54% last quarter to 27%.
- A 6% increase in behaviour support practitioners considered suitable to deliver behaviour support services.
- The number of NDIS participants with a Reportable Incident (not related to Unauthorised Restrictive practice) decreased from 6,338 in the last quarter to 6,267 this quarter, a 1% decrease.
- The median number of calendar days from audit submission to application determination has increased from 31 days last quarter to 70 days this quarter for new applications with a verification audit, and from 33 days to 84 days for renewal applications with a verification audit.
- The national rate of Regulated Restrictive Practices (as a proportion of the NDIS participant population) reduced from 2.18% to 2.13% between this quarter and last quarter.


Behaviour support

The NDIS Commission provides best practice advice to practitioners, providers and participants on positive behaviour support strategies.

Count of complaints received per quarter






Figure 3: Complaints received by primary complainant

Percentage of Complaints received per quarter, grouped by known primary complainant







Figure 4: Complaints themes

2 Known issue theme:

Alleged abuse or neglect: Abuse can be financial; physical; sexual violence; psychological or emotional harm and abuse; constraints; forced treatments and interventions; humiliation and harassments; violation of privacy; systemic abuse; physical and emotional neglect; passive neglect and wilful deprivation. An example of neglect is failing to act when there are potential or actual risks to a participant or causing detrimental harm by not providing appropriate services.

Provider policies or procedures: NDIS Providers are required to have adequate policies and procedures, which support participants' right to choice and control and foster an environment in which people feel safe to raise concerns or provide feedback. They should operate effective complaints, resolution and incident management, investigation and disciplinary processes and meet relevant NDIS Commission reporting requirements. Common examples of this category are: not having or utilising an appropriate complaints management system and the lack of a robust medication management policy or procedure.

Provider practice: This is a broad category but providers need to ensure they have adequate operational procedures, resourcing and appropriate supervision for workers to ensure supports are delivered in a safe and competent manner. This category includes any allegations of unethical or sharp practices; concerns relating to oversight and risk management of serious incidents; failing to implement behaviour support plan and strategies and inadequate management of conflict of interest, which does not support choice and control.

Worker conduct or capability: NDIS Providers are required to ensure their workers have the necessary training with the required competence to deliver the supports and services to meet the needs of people with disability. All workers and providers are required to act with honesty, integrity and transparency and adhere to the National Disability Insurance Scheme (Code of Conduct) Rules 2018 (Code of Conduct). Issues in this category include concerns staff do not having appropriate skills, lack of an induction process and training in place for staff. Worker conduct includes staff not behaving respectfully or engaging in coercive, misleading, deceptive or exploitative conduct.



In July 2024, a prioritisation model was implemented to ensure the level of response and resourcing allocated to each matter is proportionate to the assessed risk of harm to participants. While all matters continue to be actioned, the nature of the response varies based on priority. Actions may include redirecting matters to the appropriate authority, offering advice and guidance, requesting or requiring specific changes by providers or individuals, or recording for regulatory information which assists in determining future regulatory action. Detailed enquiries and compliance actions are reserved for matters that present the highest risk of harm to participants. The increase in finalisations in quarter 4 reflects the trial of the risk-based prioritisation model, which allowed us to test the framework and assess and finalise matters more efficiently. The increase is also attributable to a strategic focus in quarter 4 on finalising aged matters. This also had an associated negative impact on the percentage of matters closed in 90 days, as aged matters tend to be much older than 90 days and therefore increases the median closure time.






Compliance and enforcement

The NDIS Commission uses a range of compliance and enforcement tools to prevent and address breaches of the *National Disability Insurance Scheme Act 2013* (the Act). The NDIS Commission can impose penalties including, in the most serious cases, banning workers or providers, de-registering providers and seeking civil penalties.

NDIS Worker Screening Check

The NDIS Worker Screening Check is an assessment of whether a person who works, or seeks to work, with people with disability poses a risk to them. The assessment determines whether a person is cleared or excluded from working in certain roles with people with disability.

The NDIS Worker Screening Check is conducted by the state or territory government worker screening unit in the state or territory where a person applies for it. The worker screening unit also decides whether a person is cleared or excluded. Registered NDIS providers are required to ensure that they only engage workers who have been cleared in certain roles, called risk assessed roles.

Count of individuals who have submitted a NDIS Worker Screening Check application to a state or territory worker screening unit as at end quarter (cumulative since 1 February 2021)








Figure 9: NDIS Worker Screening Check pending applications

Count of individuals awaiting decision on their NDIS Worker Screening Check application as at end quarter¹





Figure 10: NDIS Worker Screening Check interim bar

Count of individuals who hold NDIS Worker Screening Check clearance as at end quarter³





Figure 12: NDIS Worker Screening Check exclusions







Renewal application: existing registered providers can begin the process of applying to renew their registration with the NDIS Commission if it

is six months or less until the renewal date listed on their Certificate of Registration.

Count excludes provider applications where audit recommendation not submitted to the NDIS Commission. It is the responsibility of each applicant to engage an Approved Quality Auditor to undertake an audit as part of application process.

Verification audit: providers requiring a verification audit usually deliver lower risk/lower complexity supports and services. Many providers requiring a verification audit are already subject to professional regulation as a requirement of doing business, for example through the Australian Health Practitioner Regulation Agency (AHPRA) and other professional bodies.

Count of new registered providers and deregistered providers per quarter^{5,6}





Figure 18: Registered provider count and payment claim


Regulated restrictive practices

A restrictive practice is any practice or intervention that has the effect of restricting the rights or freedom of movement of a person with disability. The NDIS Commission regulates the use of regulated restrictive practices by NDIS providers in relation to NDIS participants ¹

Count of NDIS participants associated with regulated restricted practice notifications per quarter, and as proportion (%) of total NDIS participant population²







Physical restraint: the use or action of physical force to prevent, restrict or subdue movement of a person's body, or part of their body, for the primary purpose of influencing their behaviour. Physical restraint does not include the use of a hands-on technique in a reflexive way to guide or redirect a person away from potential harm/injury, consistent with what could reasonably be considered the exercise of care towards a person.

Environmental restraint: which restrict a person's free access to all parts of their environment, including items or activities.





³ NDIS participants counted where a behaviour support plan containing regulated restrictive practices is lodged with the NDIS Commission or a registered provider has made an unauthorised restrictive practice notification to the NDIS Commission. NDIS participants associated with >1 restrictive practice type notification counted once for each restrictive practice type. 
Seclusion: the sole confinement of a person with disability in a room or a physical space at any hour of the day or night where voluntary exit is prevented, or not facilitated, or it is implied that voluntary exit is not permitted.

Chemical restraint: the use of medication or chemical substance for the primary purpose of influencing a person's behaviour. It does not include the use of medication prescribed by a medical practitioner for the treatment of, or to enable treatment of, a diagnosed mental disorder, a physical illness or a physical condition.

Mechanical restraint: the use of a device to prevent, restrict, or subdue a person's movement for the primary purpose of influencing a person's behaviour but does not include the use of devices for the apeutic or non-behavioural purposes.



Reports may include multiple notifications of the same matter, allegations of incidents, and situations where incidents occurred, but harm to the NDIS participant was avoided.

Count of reportable incident notifications (excluding unauthorised restrictive practices) per quarter, grouped by reportable incident type





Figure 24: Reportable incidents by gender

Count of reportable incident notifications (excluding unauthorised restrictive practices) per quarter, grouped by NDIS participant age band⁴




Figure 26: Reportable incidents reported to police





Figure 28: Reportable incidents notification timeframe – 5 day


